DECISION

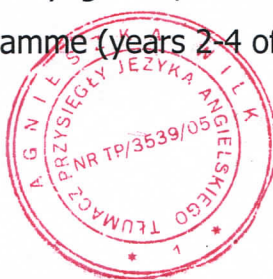
Based on art. 7a and 7b of the law on the system of education of September 7, 1991 (Journal of Laws Dz.U. No. 256 from the year 2004, item 2572 with subsequent amendments) and art. 104 § 1 of the law of June 14, 1960 – Code of administrative proceedings (uniform text Journal of Laws Dz.U. No. 267 from the year 2013, with subsequent amendments), having examined the application submitted by Professor Janusz Ostoję-Zagórski, PhD habilitatus – Rector of the Kazimierz Wielki University in Bydgoszcz, acting on behalf of the organ running the school, for a permit to establish an international unit in the Private Middle School - *International School of Bydgoszcz*,

I hereby grant

the organ running the Kazimierz Wielki University General Educational Complex *International School of Bydgoszcz*, including the Private Middle School *International School of Bydgoszcz*,

a permit

to establish an international unit in the Private Middle School *International School of Bydgoszcz*, which is part of the Kazimierz Wielki University General Educational Complex *International School of Bydgoszcz*, and to implement the International Baccalaureate Middle Years Programme (years 2-4 of this 5-year programme).



JUSTIFICATION

[Page 8, final part of decision justification]

Making the decision on granting the permit to establish an international unit in the Private Middle School *International School of Bydgoszcz*, being part of the Kazimierz Wielki University General Educational Complex *International School of Bydgoszcz*, the Minister of National Education has taken into account also the international prestige and the reputation of the International Baccalaureate organisation, which involve education quality, high standards and pedagogical innovativeness. Schools implementing programmes suggested by this foreign educational institution are subject to strict accreditation principles, and the IB authorisation itself is a characteristic international mark of education quality awarded to these schools.

As assessed by the Minister of National Education, keeping the above in mind and taking into consideration the preparation of pupils thanks to implementation of the Middle Years Programme described above, the granting of the permit to establish an international unit in the Private Middle School *International School of Bydgoszcz*, being part of the Kazimierz Wielki University General Educational Complex *International School of Bydgoszcz*, is fully justified.

Based on art. 127 §3 of the Code of administrative proceedings, the party unsatisfied with the decision may apply to the Minister of National Education for re-examination of the case. The application should be submitted within 14 days from the date of delivery of this decision.
