## Circular Letter No 10/2018/2019 of the Rector of the Kazimierz Wielki University of 10th June 2019

concerning tuition fees for education at the Non-Public General Education School Complex of Kazimierz Wielki University "International School of Bydgoszcz" from the academic year 2019/2020

Under Article 2 point 3c and Article 22 point 2 of Statute of the Non-Public General Education School Complex of Kazimierz Wielki University "International School of Bydgoszcz", later referred to as the School Complex

## I hereby inform that:

**§ 1** 

- 1. The monthly tuition fee for education in primary and secondary school level of the Non-Public General Education School Complex of Kazimierz Wielki University in a school year, paid in monthly instalments between the period of 1 September and 30 June of a given school year is:
  - 1) for the first enrolled child:
  - 1.050 PLN for persons with no tuition reimbursement,
  - 2.500 PLN for persons with tuition reimbursement
  - 2) for the second child enrolled in the School Complex:
  - 850 PLN for persons with no tuition reimbursement,
  - 2.000 PLN for persons with tuition reimbursement
  - 3) for the third child enrolled in the School Complex:
  - 525 PLN for persons with no tuition reimbursement,
  - 1.500 PLN for persons with tuition reimbursement,
- 2. Tuition fee for the annual pre-school preparation of a child aged 5 or 6 in kindergarten organized by the Primary School of the School Complex in the school year, paid in monthly instalments between the period of 1 September and 30 June of a given school year is:
- 1) for persons with no tuition reimbursement:
- 1.050 PLN if the child spends more than five hours daily at school,
- 850 PLN if the child spends up to five hours daily at school.
- 2) for persons with tuition reimbursement:
- 2.500 PLN if the child spends more than five hours daily at school,
- 2.000 PLN if the child spends up to five hours daily at school
- 3. The School Complex Headmistress in agreement with the parents determines the tuition fee for incorporating a six year old child, who is a student enrolment candidate, into compulsory educational classes and care during the school adaptation period.

- 4. Tuition fee comprises the cost of compulsory educational classes and care, pedagogical care and School Complex maintenance.
- 5. In case the tuition fee is paid for the school year (10 months) in full by 15<sup>th</sup> September of a given school year, the payer is eligible for 10% discount of the tuition fee. The foregoing does not apply to persons with tuition fee reimbursement.
- 6. The enrolment tuition fee paid by the parents before the child is admitted to school is 500 PLN. It is to be paid before 31st August of the year the education is to begin. It is to be paid either to School Complex bank account or directly at the School Complex secretary office.
- 7. Education fee for mother tongue support is 400 PLN per student monthly.
- 8. Educational fee for additional English classes is 50 PLN per teaching hour.
- 9. There is a possibility to include additional fee, e.g. for transport or student books, and subjoin it to the overall tuition fee. The foregoing requires the implementation of the relevant provisions in the Student Enrolment Contract.
- 10. The rights and obligations of the parties are regulated by the Student Enrolment Contract for a specific school type level or kindergarten unit. The contract is prepared by the School Complex Headmistress based on School Complex Statute and Regulations.
- 11. Employees of the International School of Bydgoszcz and of Kazimierz Wielki University are entitled to 50% discount on their child's tuition fee.

§ 2

This circular letter comes into force on being signed and it refers to the students who begin their education at primary or secondary school level of Non-Public General Education School Complex of Kazimierz Wielki University "International School of Bydgoszcz" in the school year 2019/2020.
