

**Circular letter No. 7a/2025/2026
of the Rector of Kazimierz Wielki University
of 10th March 2026**

regarding the amount of tuition fees in the General Educational Complex of Kazimierz Wielki University „International School of Bydgoszcz” starting from school year 2025/2026

Pursuant to § 19 section 2 in connection with § 2 section 5 letter b of the Statute of the Non-Public Primary School implementing the International Baccalaureate Primary Years Programme and Middle Years Programme, as well as the Statute of the Non-Public Secondary School "International School of Bydgoszcz", hereinafter referred to as the School Complex.

I hereby inform

what follows:

§ 1

1. The amount of tuition fees in primary and secondary school, administered by Kazimierz Wielki University, which are part of the General Educational Complex, paid monthly in the period from 1st September to 31st August of a given school year totals for students starting learning in September 2025
 - 1) for the first child attending PYP and MYP:
 - PLN 1800 for people without a refund of learning costs,
 - PLN 3500 for people with a refund of learning costs
 - 2) for the second child of the parents of a student already attending PYP and MYP:
 - PLN 1500 for people without a refund of learning costs,
 - PLN 3000 for people with a refund of learning costs
 - 3) for the third child of the parents of students already attending PYP and MYP:
 - PLN 1200 for people without a refund of learning costs,
 - PLN 2500 for people with a refund of learning costs
 - 4) for every child attending DP:
 - PLN 2000 for people without a refund of learning costs,
 - PLN 4000 for people with a refund of learning costs.
2. The tuition fee includes the charge for compulsory educational and homeroom classes, pedagogical care and operating costs of the Educational Complex.
3. If a person pays the amount of the tuition fee by 15th September of a given year, in advance for the whole school year, they are entitled to a 10% discount. The above does not apply to people who have a refund for learning.
4. The amount of a one-time entry fee paid by the Parents of a child before admission to the Educational Complex totals PLN 1000 and should be paid at the latest by 31st August of the year in which learning starts, to the bank account of the Educational Complex.
5. The charge for mother tongue support totals:

- PLN 300 – 1 hour in week
 - PLN 600 – 2 hours in week
 - PLN 900 – 3 hours in week
6. Additional fees may be added, e.g. for transport, the cost of textbooks, and included in the amount of tuition fees. The above requires the introduction of appropriate provisions into the educational contract.
 7. The rights and obligations of the parties are regulated by the educational contract in a given type of school or the kindergarten department according to the template prepared by the Principal of the Educational Complex, the Statute and the Regulations of the Educational Complex.
 8. Employees of International School of Bydgoszcz and Kazimierz Wielki University are entitled to a 75% discount on their child's tuition fees.

§ 2

The circular letter comes into force on the day of signing and applies to students starting learning in school year 2026/2027 in PYP, MYP and DP of „International School of Bydgoszcz”.
